

Area residents recall 1977 Johnstown Flood 'COMMUNITIES CAME TOGETHER'

Altoona Mirror By Walt Frank

JOHNSTOWN — Forty years ago this week, a storm described as a "once in a 5,000- to 10,000-year occurrence" hammered the city of Johnstown.

The Johnstown flood of July 20, 1977, killed 85 people, 39 of them in Tanneryville, where the Laurel Run Dam broke.

The storm began about 9 p.m. July 19, 1977, and "just got stuck over the ridges" for about six hours, dropping up to 12 inches of rain, said Richard Burkert, president/CEO of the Johnstown Area Heritage Association.

Six dams failed and more than 128 million gallons of water poured into the Conemaugh Valley.

A phenomenal amount of rainfall — 11.82 inches in 10 hours — was too much for the dams and the sewers in the Conemaugh Valley.


The National Weather Service said a once-in-a-1,000-year flood in the valley could have resulted from 7.32 inches of rainfall in a 10-hour period, according to Mirror archives.

Blair County residents and organizations responded to their neighbors to the west in need of help.

The Blair County Community Action Agency coordinated the Blair County recovery effort.

"What I remember are the target area groups we had in Blair County. We had six or seven in the city and several outside of the city. They came together to bring supplies to take over to Johnstown," recalled James Pritchard, who was agency executive director at the time.

Under agency direction, nurses from Altoona Hospital, high school and college students and Boy Scouts volunteered.

According to Mirror archives, the agency took 11 vans filled with volunteers on weekdays and full-size buses on weekends.

Food, supplies sent

It delivered 37 tons of food, 16,700 gallons of water, 25,800 pounds of ice, \$20,000 worth of medical supplies, 1,000 buckets, 20 cases of brooms, 200 pairs of boots and 100 pairs of gloves, according to an agency report on flood-related activities.

Agency vehicles logged 5,724 miles and coordinated the work of 218 volunteers who logged 3,000 hours. Eighteen additional medical volunteers logged 298 hours.

Twenty agency employees logged more than 2,000 hours.

The agency helped direct five truckloads of clothes and cleaning supplies from a CB club in Plainsville, Ohio.

"We made sure we did whatever we could do, whether it was supplies or people to get them over to assist in the cleanup, whatever was necessary," Pritchard, now 84, recalled. "I think we played a significant role. Back in those days, communities came together."

Then Altoona Mayor William Stouffer also helped lead local recovery efforts, according to Mirror archives.

By 1 a.m., six trucks of food, clothing and medical aid were on the way to Johnstown.

Collection centers were set up in Altoona, and volunteers let people know that if they couldn't deliver to the centers, donations would be picked up at their homes.

Thousands of Blair Countians sent caravans of canned food, hot food, baby food, bottled water, all sizes and types of clothing, ice, blood, blankets, sheets, disposable diapers, mops, money, buckets, time, sweat, energy, medical supplies and chain saws.

Medical supplies from Altoona Hospital were flown by helicopter, and food and clothing, drinking water and cleaning materials were trucked into the disaster area.

The Salvation Army was one of hundreds of organizations and thousands of volunteers that swarmed into the battered area to help relieve the suffering. For example, the agency sent 190 hot meatloaves from Altoona at the peak of the food brigade, according to Mirror archives.

According to the Johnstown Tribune-Democrat, 20 mobile units moved through the flooded areas serving 20,000 meals a day.

The Salvation Army also delivered food, water clothing and cleaning supplies and provided counseling and informational services.

The Salvation Army also established soup kitchens and refugee centers in cooperation with other relief agencies.

Half of Route 56 washed away

Lois Gutshall was administrator of the Allegheny Lutheran Home in Hollidaysburg in 1977 and served as an American Red Cross volunteer.

"We loaded up supplies and went; going down Route 56, half of it was washed away. We spent the night at a shelter at a school across from the Richland Mall. I took with me blankets, towels and sheets and dressings. We ended up at the shelter," Gutshall recalled.

Keystone Search and Rescue Team provided anywhere from eight to 20 workers in the flooded area of Cambria County for a period of 11 days.

They picked people off roofs, off trees and out of cars. They hunted for bodies and found them. They transported medical and other supplies. Some of them rode in helicopters and ambulances, according to Mirror archives.

Mount Aloysius College set up an emergency food relief center.

When the flood hit, Antis Township resident Ray Nycum was among 800 members and guests of the Jaffa Shrine on a weeklong cruise to Bermuda and the Bahamas.

Nycum said when he got back to Altoona he received a call from Fred Imler Sr. of Imler's Poultry, a member of the Jaffa Mounted Patrol.

Imler donated hundreds of chicken halves, and Boyd Shaw — of the former Shaw Packing of Newry — contributed many products, including sausage and hot dogs. Over a period of a few days, Imler made three trips to Johnstown to cook chicken halves.

"Ray and I got help together and built a pit with charcoal, that stirred up some excitement, when that odor flowed around town. They were so appreciative of that," Imler recalled.

"Fred's brother, Richard, provided the charcoal, and the Blair County Highway Department provided racks to cook the chicken," Nycum said. "It was amazing what these people went through. It was great we could help them with something to eat. I give a lot of credit to Fred for getting the whole thing started." there, there were eight to ten cars piled up against the building. Dan Weaver's Cadillac was stuck in the ground; you could just see the tail lights standing up. It was unbelievable, the damage," said Steve Sheetz, chief operating officer at the time. "We had property damage, and then we heard about what happened in Tanneryville, where a lot of people lost their lives."

Ward Trucking had a terminal in Tanneryville in 1977.

G. William Ward, company president at the time, and Charles "Chick" Dillen, director of customer relations, went over the morning after the flood.

"We got as close as we could get to our terminal in Tanneryville. It was right in the path of the storm. Our parking lot, it was totally washed away. One of our employees, Stan Pilot, lost his parents in the flood, they were never found. He lived above the terminal," Ward recalled. "The devastation was unreal. It was hard to believe."

"The concrete slabs of the road were up on their end. You couldn't get through," Dillen said.

"Ray and I got help together and built a pit with charcoal, that stirred up some excitement, when that odor flowed around town. They were so appreciative of that," Imler recalled.

At least two Altoona-based businesses were impacted by the flooding.

Sheetz Inc., which had 45 stores at the time, saw three of its stores damaged by the floodwaters.

"Our store on Napoleon Street downtown was flooded. At our Bedford Street location, the foundation of our store was damaged. Our store at Messenger Street had a tree trunk through the window, but the shell of the building was still standing. When we went Laird Rager, 88, of Mineral Point was a driver for Ward Trucking in 1977.

"I drove the last truck that got out of the terminal. The Laurel Run Dam burst after that. My car was parked next to the terminal. The dam burst and all kinds of debris came down. It was a Saab. I have a photo of my car with the back end raised up against the building. It destroyed my car," Rager recalled.

143RD ANNUAL IMPERIAL SESSION SHRINERS INTERNATIONAL JULY 10 - 14, 2017

Representatives of Jaffa attended the Shriners Imperial Session in Daytona Beach, Florida, led by Illustrious Sir Jerry Lower and Lady Sandy. All elected Jaffa representatives of the Iowa and Colorado Corporations attended all sessions. Chief Aide Bill Sheehan and his lady Stephanie and Paris Persun provided wonderful hospitality to our representatives and guests.

The walk, ride or drive for love was held bright and early on Sunday morning at the Daytona International Speedway. Jaffa was well represented and a good time was had by all. After a quick return to the hotel to freshen up, it was off to the church service and public opening ceremony held at the Ocean Center.

Monday morning started extra early due to the need to bus to the convention hall. The usual opening formalities took place to allow the Imperial Officers to lead all business of the Colorado and Iowa Corporations. Roberts Rules of Order were strictly followed, and various appointments were announced. The reports of standing committees were given. A special tribute was presented covering the life of deceased Imperial Officer Jack Jones outlining the many dedicated positions he had filled during his 35-year Masonic journey. William P. Salson was Parliamentarian.

A total of 696 delegates were noted as voting delegates collectively.

- A motion was made to accept all names read for the standing committees, and this passed unanimously.
- A motion was made to allow proposed business to move forward during any ballot counting; this proposal passed unanimously.
- Imperial Sir Doug Maxwell was nominated and elected as Committee Chair to lead committee of review for all records and reports.
- Illustrious Sir Jon Hansen, Chairman of the Legal Affairs section for Shrine International, explained the procedural process we would follow throughout the convention. He introduced his selected panel of legal advisors and outlined the official "Rules of Voting." A total of 50 items were on the call for this convention.
- Illustrious Sir Philip Johnson, Chairman of the Election committee, explained the balloting process.
- The first amendment to come before the delegates was Item 44 which petitioned for Master Masons of the country of Bolivia to open a new temple called Bolivia Shriners in Santa Cruz, Bolivia. The motion passed enthusiastically. This item was then followed by Item 45 which called for opening a new temple, titled Amal Shriners in Sao Paulo, Brazil. Both items passed unanimously. A warm presentation of flags and gifts of the two countries were presented to Imperial Potentate Chris Smith.
- Item 12—after much research and discussion and with approval from the Jurisprudence and Laws Committee and Dispensations and Charters Committee, a motion was made to allow the Dispensations and Charters Committee to approve a temple change of address and report such to Shriners International.
- A motion on Items 33, 40, 41 and 42 dealing with change

of location was moved and seconded to approve and accept change of address for Scimitar Shriners, Salaam Shriners, Ziyara Shriners and Bahia temples respectively. These items passed unanimously.

- Item 8, worked on by several committees to gain approval, was brought to the delegates for a vote that would change the duties of the Imperial Treasurer will coincide with the fiscal year of the corporation, which may or may not be on a calendar year. This motion passed unanimously.
- Items 32, 34, 35, 36, 37, 38, 39 and 43 were all reviewed and upon the recommendation of the Dispensations and Charters Committees and the Jurisprudence and Laws Committee, a blanket motion was made to allow affected temples to transfer membership to different geographical Shrine associations.
- Item 26—a motion was brought forth by the entire Imperial Divan, having been passed through all proper channels, to allow the Imperial Potentate authority to grant dispensation allowing non-Nobles to participate in a parade at the annual session of Shriners International. Motion passed unanimously.
- Item 15 on the call makes clear the language in Article 23 that all temples will elect members by a majority vote of the written ballots cast.
- Item 18 on the call changes the language of Article 23, Section H, that deals with balloting for International Shrine Clubs that they be permitted to follow balloting as set forth in Item 15 above.
- Item 31—pass unanimously that Hikmat Shriners will have exclusive jurisdiction in states of Bahia and Minas Gerais.
- Item 21—passed soundly. This item deals with resolving Article 30—complaints from a noble against another

noble of conduct unbecoming a noble. The language and procedural changes should stop any complaints filed in bad faith or being frivolous in nature.

- Item 22—passed soundly. This Item is a change to Article 30 that will make it possible that if a complaint cannot be resolved at the temple, the grievance committee, assigned by the Imperial Potentate, will review, and if it finds by a majority vote that there is no probable cause that an offense has been committed and the complaint was possibly filed in bad faith or for frivolous reasons, the committee can fix the punishment to the complaining noble for filing a complaint in bad faith. The aggrieved noble could then appeal such complaint.
- Item 13—a temple may change locations if a written proposal is signed by 100 members or 10 percent of the members, whichever is less. Passed unanimously.
- Item 2—This proposal will change wording that all amounts payable to Shriners International is stated and payable in United States dollars. Passed soundly.
- At this point of the convention, it was time to break away from voting on articles. The first report was from the Oversight Committee. Their first sub-committee was on our investments and spending; report expressed that all transactions and records were in proper form and that they received good cooperation from all interviewed during the process. A question arose concerning money spent on public relations and it was explained that it is difficult to quantify branding and numbers of interest through social media. All TV ads and interest in sporting events showed rising numbers of viewers. A motion to accept this report received a unanimous vote.
- The committee pointed out a flaw and recommended that we vote to extend the stay of the Imperial Divan since they are needed to be in session some days before and after the Imperial Session. It was explained that in order to conduct business, these officers had to pay out of pocket for these additional days. The motion passed unanimously.
- Next the delegates heard from the Planning and Audits Committee. The good news is that for the final closeout of 2016, it shows that revenue exceeded expenses. It was stated that the per capita increase and conservative spending of Shriners International accounted for positive numbers. The budget for 2017 has been reviewed and recommendation to accept was made and unanimously approved to accept the budget as in its current state. The final audit report for 2015-2016 was reported that all outstanding bills cleared and all budget categories balanced correctly. A motion was made and unanimously approved to accept this report.
- The Shriners International budget for 2018 was reported on and showed no discrepancies in the line item numbers.

It was recommended we adopt the proposed budget by voice vote and the motion passed unanimously to accept.

- The Shriners Hospital report was presented showing a major shortfall due to interest on savings being down. Net assets for the corporation did increase due to donations rising. It is believed that the TV ads featuring "Alex", our somewhat famous voice and face, have contributed greatly. A motion to accept the hospital report was unanimously passed.
- The 2018 hospital budget was presented with a plan to decrease expenditures. This budget proposal passed with a unanimous vote.
- A report by our Imperial Treasurer, Jim McConnell, was given. Shriners International showed a gain for a second year mainly due to the per capita increase and improvement in net assets with investments. A motion to accept Mr. McConnell's report was unanimous.
- The Shrine Hospital report was given by Past Imperial Sir Jerry G. Gantt. Highlights include that the hospitals are doing well, all thought operation expenses outpriced revenue and the financial picture is solid. The Colorado Corporation is strong in net assets and has no long term debt. The endowment fund is stable and our line of credit allows us to leave the endowment fund to continue to draw a strong interest rate. It was by unanimous vote by all delegates to accept the Shrine Hospital report.
- Item 50 of the call was brought forth by incoming Imperial Potentate Gary Bergenski. This resolution allows the hospital oversight committee to continue as established at the 2012 Imperial Session. A motion was made and passed unanimously on this issue.
- The afternoon session commenced with nominations and voting on the Imperial Officer line and acceptance comments. The only contested office was for Imperial Outer Guard and Noble Lawrence Leib received a strong enough majority to be elected to the Imperial Line.
- The business resumed with 40 items on the call. Item 3 of the call was directed at Article 1, parliamentary procedure. The motion to utilize the most current edition of Roberts Rules of Order Newly Revised was presented and by unanimous vote the motion carried.
- Item 25—a motion that would allow a temple to obtain from Shriners International the names of nobles living within a temple's jurisdiction, but who are not members. After much discussion, a motion was made and was accepted by a majority vote.
- Item 20 on the call made clear language of Article 29 dispensation and charter for new temple. A petition for a new temple would be void unless specifically extended by Shriners International 60 days prior to the third Imperial Session following the issuance or after the third unsuccessful filing.

143RD ANNUAL IMPERIAL SESSION

Monday's session concluded at 4:30 p.m. with a tired group of delegates. An awful lot of dedicated work was accomplished on this first day. That evening, we enjoyed fellowship and dinner near the beach stage.

Tuesday's session began with a report from Imperial Sir Gary Bergenske on behalf of the Capital Evaluation. He outlined the great work his committee has done with no travel money having completed all business over the telephone. The main items presented were designed to improve the bottom dollar for our fraternity, such as an Education Foundation which would be a tax-deductible donation and would be used to help cover the cost of Shrine schools held through Shriners International; publishing a member directory; a life membership based on age and a member benefit program. All above mentioned ideas will continue to be worked on this coming year.

An interesting report was given by Imperial Officer Jerry Gantt for the Colorado Corporation. Through our hospital burn units, Shrine doctors and medical staff flew to Guatemala to assist after a tragic fire at an industrial complex which badly burnt several people. Our medical staff, within hours, flew into the country and proceeded to treat these patients. Once stabilized, many were then flown to several of our burn centers for treatment with some taking many months until they reached a healthy point in which to travel back home and return for follow-up procedures as necessary.

Mr. John McCabe, Colorado Corporation COE, presented a corporation update that included how we have recently invested in new facilities, equipment and technology and professional staff development. He outlined how the Affordable Care Act has affected us but that referrals are up, patient use has seen a 5 percent increase, and so far, we are seeing a market value increase in the past 12 months.

Imperial Officers Ken Cravin and Jeff Sowder gave an update on our four sports sponsor coverage events that bring recognition to Shriners. The East-West Shrine Game, David Regan Auto Racing, the College Classic of Baseball and the Shrine Classic Golf Tournament. The four events are bringing brand recognition to our hospitals and all the fine work we do are outlined with the help of our patient ambassadors.

The session moved back to the business of the delegates. A motion to fill the vacant board position previously held by Rick Williams to be filled by Imperial Sir Jerry Gantt was unanimously approved. A motion made for Jerry Gantt to be named president chairman of the hospital board was also unanimously approved. A motion to elect all current hospital board members as a whole passed soundly as a one solid voice vote.

The Donor Relations report highlighted many positive points that we should be proud of as Shriners. We have a 4-star rating on the governments rating list. We are the second most requested brand of hospital in the United States. All sub-sections of our donor programs have shown substantial increases.

Imperial First Lady Ethel Smith gave her report on her 2016 project, "The Sky's the Limit". This project sent sick and injured children to outdoor adventure camps to help build confidence and to have fun.

Our patient ambassadors for 2017-2018 were introduced. Isabella Rose presented a beautiful song she helped to write while working with music therapy specialist Jackie Machi at our Philadelphia hospital. Pennsylvania is leading the way with ambassadors as we have Emily for our Erie hospital. She is doing fundraising by making bracelets for donations in a program she calls "Beads for Needs." This concluded Wednesday's session.

The Thursday session was fast-paced as many delegates had planes to catch. Items to note are:

- Item 4—motion moved to change notice for special sessions from 30-day to 10-day notice by first class mail. Motion passed unanimously.
- Item 24, Article 34—insurance at all temples. The language was cleaned up to match industry standards used in today's policies. Motion passed unanimously.
- Item 46—this amendment to Article 5 changes the principal place of business of the Colorado Corporation from Denver, Colorado, to Tampa, Florida. Motion passed unanimously.

Closing comments from our Imperial Potentate Chris Smith brought the 2017 Imperial Session to an end.

Ruth Ann's grip improves after cleft hand surgery

Four-year old Ruth Ann was born with cleft hands and feet due to a genetic-trait abnormality. Complications were minor and several doctors advised her mother, Njeri Bernard, to wait until Ruth Ann reached a certain weight and height to correct her hands and feet.



"Although Ruth Ann's condition was not painful and only had some minor effects, I wanted to explore all our options, especially since she would be starting kindergarten the next year," said Njeri.

Njeri took Ruth Ann to see several doctors in the New York City area. "I went from Brooklyn to the Bronx and back to Brooklyn looking for the best doctors and the best doctor I could find at NYU [New York University] referred me to Dr. Kozin [Scott Kozin, M.D., lead orthopaedic surgeon and chief of staff at the Philadelphia Shriners Hospital]." After their first visit, a care plan was created and Ruth Ann was scheduled for surgery with Dr. Kozin. Ruth Ann underwent a right hand reconstruction surgery to remove her duplicate thumb and separate the other fingers that were fused together.

Njeri was impressed with the care at Shriners Hospitals for Children — Philadelphia. "Everything was so clean. The hospital, the people, the care were all superb. It surpasses all the places I've ever been and I have been to a lot of places," said Njeri. "It's different, the nurses are not just nice when the doctors are there. Someone even called to update me about the progress of my daughter's surgery, and that meant a lot to me."

Now, just weeks after surgery, Ruth Ann already has a better grip and can count better on her hands. Because surgery went so well, options are being explored for her left hand and her feet.




